Treasurer's Report: (Cindy)

In the Annual Meeting handout package, there were two financial sheets for your review:

- 1. CCPA Calendar Year 2021 Budget vs. Actuals
- 2. CPPA Calendar Year 2022 Budget

2021 Budget vs Actuals:

Cindy reviewed some of the line items in this 2021 financial sheet.

The budget for CY 2021 ended with a positive net income of \$5,161.41. Expenses were \$2,780.41 below budget. In reviewing the bank information, it showed \$23,301.68 in the First Internet Bank and \$2,272.90 in the Coastal States Bank account.

Cindy discussed the expenses and noted that We are keeping the pool area open throughout the year. Swimming is restricted from November 1 until April 1. Cleaning service/Garbage is removed twice per week during the on season and 1 time per week during the off season.

2022 Budget:

Cindy utilized the previous year's history for projecting the new 2022 budget. Electricity expense went down due to Ron Zmuda's (Board Member) suggestion to only run the pool pumps 10-12 hours per day when the pool was closed for swimming. This budget was established with \$47,170.14 for expenses, which includes a 10% reserve of \$5,050.14.

Cindy - Calendar Year 2021 Recap items:

- The website is: www.crookedpond.net. All information about CPPA is listed on the website including the Board meeting schedule and minutes, financials, and important documents such as insurance policies, Covenants, By-Laws, and pool rules. You can send messages to the CPPA Board from this website.
- New security system Fobs seems to be working well. It helps restrict the use of the facilities to members and their guests. The Fobs will be activated past the existing deactivation date of March 31, 2022, once the member pays their assessment.
- New pool pumps due to failure of the pumps. Upgraded to current code.
- New electrical service panel
- New bathroom light fixtures
- New outside building motion sensitive and photocell controlled

- New exhaust fan in the pump room
- Added new rigid insulation in the pump room
- New security system, cameras and fobs
- New wall mounted water cooler
- Pickleball squeegee
- Replaced the old picnic table and added 2 more
- Added another bench in the pickleball/tennis area
- Continued use of the welcome letter containing information about the Crooked Pond neighborhood sent to new property owners.
- An additional bench was purchased and installed on the pickleball side of the courts.
- Continued the pool deck and bathrooms open all year.
- Bathrooms cleaned twice per week from May 1 until Labor Day.
- Bathrooms cleaned once per week after Labor Day April 30th.
- Continued the use of code for the bathroom locks.

Cindy - Plans for Calendar Year 2022:

- Paint the pool building, interior of bathrooms and exterior, except the metal roof.
- We have a new cleaning company Low Country Special Touch Services
- Create a pickleball/tennis Committee to review policies and capital improvements
- Properly clean the court surfaces
- Add pickleball/tennis gate closure
- The need for pool deck resurfaces (possibly 2022 2023)
- Parking lot repair, sealing and stripping (2023 = 2024?)
- Resurface the pickleball/tennis courts (2023 2024?)
- A new picnic table will be purchased and placed in the same location as the old one.
- A schedule of Board meetings was attached in your handout and placed on the website. New Board members are encouraged to volunteer to be a Board member, and everyone is encouraged to attend Board meetings.
