# **2022 Budget vs Actuals:**

Cindy reviewed some of the line items in this 2022 financial sheet.

The budget for CY 2022 ended with a negative net income of (\$7,139.27). Expenses were \$6,703.70 over budget. The major expenses creating this over budget were for repair of the sand filters and tree removals.

Cindy discussed the expenses and noted that We are keeping the pool area open throughout the year. Swimming is not allowed from November 1 until April 1. Cleaning service/Garbage is removed twice per week during the on season and 1 time per week during the off season.

### 2023 Budget:

The Board sent out the 2023 budget with the invoice for the assessment.

## Ron - Calendar Year 2022 Recap items:

- Continued the use of the fobs and welcome letter containing information about the Crooked Pond neighborhood sent to new property owners.
- An additional bench was purchased and installed on the pickleball side of the courts.
- Continued the pool deck and bathrooms open all year.
- Bathrooms cleaned twice per week from June 1 until Labor Day.
- Bathrooms cleaned once per week after Labor Day May 30th.
- Continued the use of code for the bathroom locks.

### **Ron - Plans for Calendar Year 2023 and beyond:**

- Resurface the Tennis/Pickleball courts estimate September start date and courts down for about 2 weeks.
- Continue the Tennis/Pickleball Committee to review policies.
- Properly secure the Tennis/Pickleball courts
- Pool deck resurfaces (possibly 2024)
- Parking lot repair, sealing and stripping (possibly 2024)
- A new picnic table will be purchased and placed in the same location as the old one.
