#### Revised December 2022 Financials:

#### Budget vs Actual:

Cindy produced a revised report and sent to all Board Members prior to the meeting two financial reports. It showed budget vs. actual along with total Calendar Year. Revised December 2022 income was \$349.40. December's expenses remained the same at \$8,185.06. Revised Year-to-date 2022 income was under projected budget by \$435.57. The expenses for the calendar year 2022 were over budget by \$6,703.70.

# January 2023 Financials:

#### • Budget vs Actual:

- Cindy produced a report and sent to all Board Members prior to the meeting two financial reports. It showed budget vs. actual along with total Calendar Year. January 2023 income was \$18,700.08. January's expenses were \$2,560.33. Revised Year-to-date 2023 income was over projected budget by \$682.08. The expenses for the calendar year 2023 were under budget by \$828.67.
- The First Internet Bank account as of 1/31/2023 at \$19,601.12. The Coastal States Bank as of 1/31/2023 was at \$18,139.94. This produced a total, as of 1/31/2023, of \$37,741.06. Operating Funds as of 1/31/2023 were \$19,199.26. The reserve Fund as of 1/31/2023 was \$18,541.80. This produced a total as of 1/31/2023 of \$37,741.06.
- Status of Assessment Collection: 59 properties paid as well as 4 properties for past due 2022 amounts. Suzanne made phone calls to past due accounts.
- Copies of liens on 2021 delinquent properties: No copies have been found so we must assume this never was filed.

- o Pickleball/Tennis Committee update: Ron reported that nothing is new.
- Schedule of play policy recommendation: Suzanne has the name of the software package to coordinate scheduling of play for the court. She will review and get back with us.
- Additional striping for additional pickleball court: In obtaining quotes for the resurfacing of the courts it was decided to have the permanent pickleball court on the right-hand side and then the left side would be the tennis court and also striped for pickleball. There was a discussion to have the right court also striped for tennis.
- o **2020/2021/2022 Audit Process/status:** The audits are not expected to be completed by the annual meeting.

#### Other Business:

Reserve analysis – projects to be completed in 2023: Nothing new.

Resurface estimate for the tennis/pickleball courts: Doug, Sheri and Ron requested that three (3) bids hopefully will be received.

Other means of collections for delinquent properties: Jay suggested that a new attorney be researched so this issue of liens and collections can be cleared up. He suggested an attorney that is involved with other HOA's. His name is Rick Haight. Jay will followup.

**Water Cooler repair & winterize procedure:** Jim now has the parts. Jim said he would speak with Butler Plumbing to install the new parts.
